14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On March 1, 2024, Southwest Gas Holdings, Inc. ("SWG") paid a quarterly distribution of \$0.62 per share to its shareholders of record as of February 15, 2024.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ The character of a distribution as either a dividend or a return of capital for federal income tax purposes depends on SWGH's estimate of earnings and profits. This form was prepared based on estimates as of the date the form is posted to SWGH's public website. Estimates can change throughout the year, which may change the expected character of the distribution. In the event this occurs, SWGH will file a corrected Form 8937 for impacted distributions pursuant to applicable Treasury Regulations.

Based on current estimates, 100% of the distributions paid on March 1, 2024 are nondividend distributions, which reduces the shareholder's cost basis in their shares of the Issuer on which the distribution was paid. The nondividend distribution in excess of the shareholder's cost basis in their share of the Issuer may be treated as capital gain. SWGH is providing this form for information purposes only. 16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ Issuer's computation of earnings and profits for the year ending December 31, 2024 was estimated in March 2024. Pursuant to Internal Revenue Code sections 301(c) and 316(a), the taxability of the distribution is based on SWGH's earnings and profits computed for U.S. federal income tax purposes. SWGH's estimated current and accumulated earnings and profits applicable to 2024 distributions supports the expectation that 100% of the March 1, 2024 distribution is a nondividend distribution, which is a nontaxable return of capital to the extent of the shareholder's basis.
